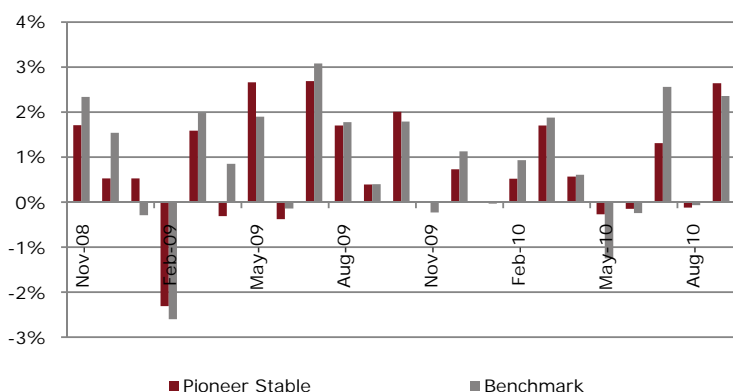

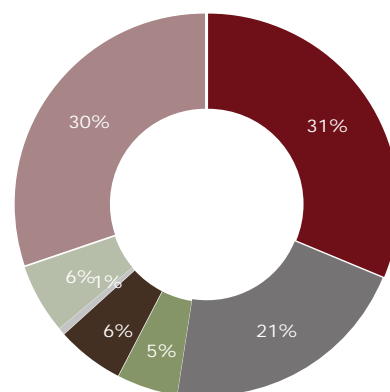

INVESTMENT MANAGERS
